# Monthly Report On Government Borrowing from Domestic Sources<sup>1</sup>

July-October, FY19

### **Government Borrowing from Domestic Sources in July-October, FY19**

The government borrows from two domestic sources: banking system through Treasury Bills (T-Bills) & Bonds and the non-banking system mainly through National Savings Directorate (NSD). Instrument-wise govt. domestic borrowing (net) during July-October, FY19 is depicted in Figure-1.




Figure-1: Instrument-wise Govt. Domestic Borrowing (Net) during July-October, FY19

Govt. domestic borrowing (net) stood at Tk. 18279.6 crore during July-October, FY19 after the adjustments with T-Bills and Bonds, NSD, Ways and Means Advances (WMA), advances to Food Ministry and other Ministries, Overdraft (OD) current and block accounts, accrued interest, and advances and deposits of autonomous and semiautonomous bodies, balances of GIIB (Government Islamic Investment Bond) fund as well as deduction of cash balance in the form of govt. deposits with Bangladesh Bank and scheduled banks (i.e. including banking and nonbanking sources).

It may be noted that the amount was Tk. 14420.1 crore and Tk. 12996.5 crore during July- September of FY19 and July-October of FY18 respectively. The govt. domestic borrowing (net) during July-October, FY19 is 40.7 percent higher than that of the same period of the previous year. It may be mentioned that Govt. borrowed Tk. 17828.8 crore through NSD instruments in July-October, FY19. It is observed that govt. deposits decreased by Tk. 617.1 crore (net) with the banking system during this period. Deposits with Bangladesh Bank (BB) increased by Tk. 22.1 crore and deposits with scheduled banks (SBs) decreased by Tk. 639.2 crore.

Govt. borrowed (net) Tk. 5150.7 crore through T-Bills and Bonds to the banking system during July-October, FY19.

From Figure-2, it is observed that the net borrowing from banking system was positive in July, FY19.

During July-August of FY19 and July-September of FY19, the Govt. borrowing increased through banking system as well.

The Govt. borrowing increased by Tk. 343.5 crore through banking system during July-October, FY19.

In addition, non-bank govt. borrowing (net) stood at Tk. 17936.1 crore during July-October, FY19.

As a result, govt. borrowing (net) from the domestic sources in July-October, FY19 stood at Tk. 18279.6 crore. The movement in net govt. borrowing from different domestic sources during July-October, FY19 is demonstrated in Figure-2.




Figure-3: Monthly Trends in Government Domestic Borrowing during July-October of FY19

Figure-3 shows the monthly movement of government net domestic borrowing July-October, FY19.

During the month of October, 2018, Govt. domestic borrowing increased by Tk. 3859.5 crore (borrowed Tk. 4060.8 crore from BB, Tk. 4287.6 crore from nonbank and repaid Tk. 4488.9 crore to SBs) which is Tk. 5642.0 crore higher than that of the month of September, 2018. In the budget of FY19, Tk. 71227.0 crore has been fixed for borrowing from domestic sources by the government of which Tk. 42030.0 crore and Tk. 29197.0 crore have been targeted to borrow from banking and non-banking sources respectively.

During July-October of FY19, the net repayment and holding of cash balances with Bangladesh Bank stood at Tk. 8068.2 crore. On the other hand, the net borrowing from scheduled banks stood at Tk. 8411.6 crore during the same period.

A comparative picture of government total budget target and actual domestic borrowing situation during July-October of FY19 is shown in Figure-4. Government total borrowing from other than banks (including NSD, T-Bills and Bonds) stood at Tk. 17936.1 crore of which Tk. 17828.8 crore was borrowed through NSD instruments during July-October of FY19. The total net government domestic borrowings (banking and non-banking sources) stood at Tk. 18279.6 crore during July-October of FY19 which is 25.7 percent of total budget target.

# **Major Findings of the Govt. Borrowings from Domestic Sources:**

- From banking system, total outstanding of Govt. domestic borrowings increased by Tk. 3.4 billion during July-October of FY19 compared to the outstanding of Govt. domestic borrowings of June, FY18.
- Govt. borrowed Tk. 179.4 billion (of which Tk. 178.3 billion through NSD instruments) from other than banks during July-October of FY19, which is 61.4 percent of the Non-Bank budget target.
- Government borrowings from NSD instrument is significantly increasing due to its relatively higher interest rate than other savings rates.
