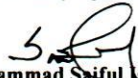

**2. Conditions:**

- If they receive scholarship/grant from any public/private/international organization during the course, the same amount will be adjusted from the fund payable by Bangladesh Bank;
- They cannot obtain or apply for permanent residence or green card or citizenship in any country by themselves or through their spouse during the study. Doing so will result in immediate cancellation of the scholarship and enactment of legal action against them;
- They are obligated to work in Bangladesh Bank for a minimum of 5 (five) years after returning from deputation. If any of them resigns before the aforementioned period or stays absent from office without the concerned authority's prior approval, the Bank will recover all the salaries and allowances paid during the deputation and all the expenses related to this Master's program borne by the Bank from them or their nominated guarantors;
- If he/she abandons or fails to complete the program, he/she will be obligated to return all the money received as salaries, allowances, and all the expenses related to this Master's program borne by the Bank;
- If he/she does not join the Bank in due time, his/her guarantors will be obligated to pay all of his/her salaries, allowances, all the expenses related to this Master's program borne by the Bank, loans and advances with interest according to the conditions of the guarantee bond signed by them;
- The period of deputation will not be extended under any circumstances;
- The approved program and the university cannot be changed under any circumstances;
- They cannot apply for any other higher education (e.g. M.Phil/Ph.D) program while studying;
- If any false information or any kind of fraudulence is found in the application, the scholarship will be cancelled immediately and legal action will be taken against him/her;
- Their salaries and allowances will be deposited in local currency;
- They must notify his contact address in Australia to training.hrd@bb.org.bd/gm.hrd2@bb.org.bd through email without any delay;
- Within 7 (seven) days of his arrival in Australia, they must report to the Bangladesh Embassy located there;
- The progress reports of their studies must be sent to training.hrd@bb.org.bd/gm.hrd2@bb.org.bd by email to the Director (HRD-2) of Human Resources Department-2 along with documentary evidence on a half-yearly basis;
- They will compulsorily join at Human Resources Department-1 of Bangladesh Bank on the next working day after returning to Bangladesh;
- They must write a note of acknowledgement on the Bangladesh Bank Financed Master's Program in the acknowledgement section of each publication;
- They have to submit the degree certificate/documentary evidence to Human Resources Department-2 and Thesis/Dissertation/Term Paper (both in hard copy and soft copy format) in the Research Department (Library) within 7 days of joining the Bank;
- During their studies, they must strictly comply with all the rules and regulations of Bangladesh Bank and must not do anything that may harm the reputation of Bangladesh or Bangladesh Bank.
- Bangladesh Bank may change, modify, add or remove any of the terms and conditions (including financial benefits) of the program at any time.
- In any other situation that arises, Bangladesh Bank Higher Education Policy, 2024 will be followed.

This order is issued as per the approval of the competent authority.

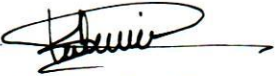
