Official Foreign Visit

Dr. Md. Habibur Rahman (Passport No. A10063422), Deputy Governor of Bangladesh Bank has been conveyed the sanction of the Government of the People's Republic of Bangladesh along with eleven other officials of different Ministries and Institutions vide letter No. 09.00.0000.000.072.25.0133.26.296 dated 27 August 2026 of Ministry of Finance to attend the Annual Meetings-2026 of the World Bank Group (WBG) and the International Monetary Fund (IMF), other bilateral meetings and associated side events to be held in Bangkok, Thailand from 12-18 October 2026 under the terms and conditions mentioned below:

Terms & conditions :

- a. The period of his participation in the Annual Meetings, other bilateral meetings and associated side events, including transit, shall be treated as on duty.
- b. He shall draw his usual pay and allowances from Bangladesh in local currency as admissible under the existing rules and regulations.
- c. All expenses for the said visit shall be borne from the budget of Bangladesh Bank as per existing rules and regulations.
- d. He may leave Dhaka for Bangkok on 12 October 2026 or a nearest possible date and leave Bangkok for Dhaka on 18 October 2026 or a nearest possible date after completion of the meetings.
- e. He shall not be allowed to stay abroad beyond the approved period.

To attend the program, he will be treated as released from his duties after the close of business of **08 October 2026** (09-10 October 2026 are weekends). During the absence, the official duties of Dr. Md. Habibur Rahman will be overseen by Mr. Md. Sarwar Hossain, Deputy Governor in addition to his duties.
