 - b) Satisfactorily completed at least 01(one) no. substation worth not less than Taka 5.0 Crore (Taka Five Crore) only in a single contract, in any Government/Semi-Government/ Autonomous Organization during the last 05(Five) years. The Tenderer shall have to furnish work completion certificate in this respect from officer not below the rank of Executive Engineer or equivalent.
 - c) Liquid asset/Credit facility shall be Tk 5.50 Crore (Taka Five Point Five Zero Crore) only.
 - d) Tenderer shall have to fulfill the qualification criteria stipulated in the ITT, TDS, GCC, PCC and other Terms & Conditions of the Tender Documents; failing which the Tender shall be rejected and considered as non-responsive.

 - iii) Tenderer shall provide all documentary evidences (original or attested whichever necessary) as per tender document, failing which the Tender shall be considered as non-responsive.
 - iv) Tenderer shall submit Valid ABC Category Electrical Contractor and Electrical Supervisory License from Electrical Licensing Board, Bangladesh.
 - v) PG3-1 and PG3-2 form shall be completed and signed by the Authorized Signatory on the Letter-Head Pad attached by Scanning during submitting tender through Web and original shall be sent to the General Manager(Engineering), Common Services Department-2 within scheduled time as per TDS.
 - vi) Furnishing of any false, misleading documents may result in rejection of tender and may lead to action under Rules 127 of PPR 2008/Reg. 12 of BBPR 2004.
 - vii) All sorts of safety and security measures shall be carried out by the Contractor during execution of work.
