(iv) The minimum amount of Liquid assets i.e. working capital or credit line(s) of the Tenderer shall be Tk.30(Thirty) Lac only. Incase of credit facilities, Bank ensures that the above mentioned credit limit will be given if the said work is awarded to the contractor. (v) Country of manufacturing certificate in original.
