The Tenderer (contractors/firms) also should have the specific experience of supply, installation, testing & commissioning of photokiosk, Audio guide, Digital signage, touch screen kiosk, security & safety equipment, Electrification, interior works along with airconditioning works under a single contract worth not less than Tk.5.0(five) crore in any Government/Semi-Government/Autonomous/Firms registered with joint stock companies during the last 05(five)years. The Tenderer (contractors/firms) shall have to furnish certificate in these respects from the officer not below the rank of Executive Engineer of equivalent and shall meet all other criteria, terms and conditions as specified in the tender document. iii) Minimum average annual Turnover in the last 05 (five) years preceding the date of submission of the tender shall not be less than Taka 5.5 (Five point five) crore . vi) Minimum liquid assets/credit facilities shall be Taka 2.75 (Two point seventy five) crore.
