05	Bidders Qualifications	:	This Invitation for Tender is open to all eligible Contractors/ Construction Firms of Bangladesh who have : i) Overall construction experience of 10 (ten) years and satisfactorily completed at least 01 (one) works of similar nature (<i>i.e</i> Retrofitting & strengthening works / New civil construction works) worth not less than Tk. 60.00 lakh (Taka sixty lakh only) in a single contract, in any Government /Semi-Government /Autonomous organization of Bangladesh during the last 5(five) years. The Tenderers shall have to furnish certificates in this respect from officer not below the rank of Executive Engineer or equivalent. ii) Minimum Average Annual Construction Turnover in the last 05(five) years preceding the date of submission of the Tender shall not be less than Tk.90.00 Lakh (Taka ninety lakh only). iii) Minimum liquid assets/credit facilities shall be Tk. 20.00 lakh (Taka Twenty lakh only). In case of credit facilities Bank will ensure that the above mentioned credit limits will be given if the said work is awarded to the contractor. iv) Tenderers shall have to fulfill the qualification criteria stipulated in the Tender Data Sheet & other Terms and Conditions of the Tender Documents.
