You are hereby invited to submit the tender for Appointing Contractor for Daily Operation, Trouble shooting, Maintenance, Repairing and Servicing of Electrical and Electronic System viz. Electrical Sub-Station, Generator, Internal & External Electrification System, Fire Detection & Alarm system, Public Address System, Auditorium Sound and Lighting System installed at Bangladesh Bank Training Academy(BBTA), Mirpur, Dhaka for three years. Brief description and terms of reference are given below:

02.	Source of Fund	: Bangladesh Bank's own fund
03.	Name of the Work	: Appointing Contractor for Daily Operation, Trouble shooting, Maintenance, Repairing and Servicing of Electrical and Electronic system viz. Electrical Sub-station, Generator, internal & area/external Electrification system, Fire Detection & Alarm system, Public Address system, Auditorium sound and lighting system installed at Bangladesh Bank Training Academy(BBTA), Mirpur, Dhaka.
04.	Time for work	: 36 (Thirty Six) months.
05.	Method of Procurement	: Open Tendering Method (OTM); National.
06.	Qualification of Tenderer	: (a) The minimum number of years of general experience of the Tenderer in Electric Installation Works as Prime Contractor shall be 10(Ten) years. (b) The minimum specific experience as a Prime Contractor of Electrification work including Sub-Station minimum 800KVA (Transformer, HT< Switchgear, PFI panel and its components), Generator (minimum 250KVA), Fire Protection system (for at least 05-storied building) and other External Electrification works during last 05(Five) years under a single contract not less than TK.70 (Seventy)Lac in any Government/Semi-Government/Autonomous Organization of Bangladesh. (c) The required Average Annual Turnover of the Tenderer shall be at least Tk 0.18 crore (18 lac) over the last three years. (d) The minimum amount of liquid assets i.e. working capital or credit line(s) of the Tenderer shall be Tk 0.10 crore (10 lac) . (e) Updated Trade license, Income Tax clearance Certificate and VAT Registration Certificate. (f) Updated ABC Electric contractor license and Electric supervisory license from Electric licensing board, Government of Bangladesh. The tenderers shall have to furnish certificate in this regard from officers not below the rank of Executive Engineers or equivalent without which tender will not be considered.

The Tenderer shall submit tender and scanned copy of documentary evidence through Bangladesh Bank Web site (e-Tendering) & must have valid e-mail address for registration & participation in e-tendering. ii. Tenderer should provide documentary evidence etc. (attested or original whichever necessary) when requested, failing which the Tender may be considered as non-responsive. iii. The Tenderer shall submit "PSN-1", "PSN-2", "PSN-3" and "PSN-4" as per format given in Tender Document and attached during submission of tender in web (as pdf format). iv. Furnishing of any false, misleading documents may result in rejection of tender and may lead to action under Rules 127 of PPR 2008/ Reg 12 of BBPR 2004. v. All sorts of Security and Safety measures shall be carried out by the firm during execution of the work. vi. Bangladesh Bank reserves all right to accept or reject any or all the Tender without assigning any reason whatsoever. No claim will be entertained in this regard.
