(iii) Tenderers shall have experience in successfully supply, installation, testing, commissioning of at least 01(One) set Archway Metal Detector in any Govt./Semi-Govt./Autonomous Organizations in Bangladesh in the last 3(Three) years. The Tenderers shall have to furnish experience certificate in this respect not below the rank of Executive Engineer or concern official. (iv) Country of manufacturing certificate in original. (v) The material deviated Tender document shall not be considered. (vi) Tenderer shall submit the Manufacturer's Authorisation on the Letter-Head Pad in original at the time of opening of the Tender. (vii) Minimum amount of Liquid Assets/Credit facilities shall be Tk. 5(Five Lac) only.
