The **DG** is the top executive of BIBM, responsible for overall leadership, strategic direction, and operational management.

BIBM is searching for the dynamic and transformational leader to fill the position of its DG, who meets the following criterion:

- Must be a Bangladeshi National, may not be more than 60 years of age on June 30, 2025.
- Should possess minimum Masters or equivalent degree preferably in Banking, Finance, Economics, Business Administration, or related disciplines;
- At least 25 years of work experience and currently holding/held a position of Executive Director of Bangladesh Bank or a position of Deputy Managing Director of any reputed commercial bank;

- The candidate must have demonstrated leadership qualities and excellent organizing, analytical and problem solving skills. The candidate must have interpersonal communication and collaboration skills to work with cross functional teams.

Salary and Compensation:

- i) Basic Salary: BDT 2,00,000/- per month
- ii) House Rent Allowance: BDT 1,20,000/- per month
- iii) Medical Allowance (10% of Basic Salary): BDT 20,000/- per month
- iv) Transportation Facility and other compensations as per BIBM policy.
