REVIEW OF IMPORT PAYMENTS OF GOODS AND SERVICES, 2020-2021

Import Payments of Goods: The total merchandise Import Payments of Bangladesh (including imports of EPZ) during the years 2020-2021 and 2019-2020 amounted to Taka 461360.2 crore (or US\$ 54402.6 million) and Taka 412852.4 crore (or US\$ 48699.9 million) respectively, reflecting a 11.71% increase in dollar terms.

Import Payments of Services: The total Import Payments of Services during the years 2020-2021 and 2019-2020 amounted to taka 61115.6 crore (or US\$ 7206.5 Million) and taka 58794.1 crore (or US\$ 6935.0 Million) respectively, reflecting a 3.91 % increase in dollar terms.

The overall position of Import Payments of Goods and Services in Taka and US dollar for the years 2020-2021 and 2019-2020 are shown in Table –I(A) and Table-I (B) respectively:

The Import Payments during the year 2020-2021 amounted to Tk. 432404.2 crore as against Tk. 386249.0 crore during the previous year showing an increase of +Taka 46155.2 crore (or 11.9%). Commodity-wise classification revealed increases over the previous year under textiles and textile articles (+Taka 7918.3 crore), mineral products (+Taka 3550.9 crore), Vegetable Products (+Taka 10765.7 crore), Products of the Chemical or Allied Industries (+Taka 6721.6 crore), Base metals and articles of base metal (+Taka 2359.2 crore), Plastics and rubber and articles thereof (+Taka 5895.2 crore), Vehicles, aircraft, vessels and associated transport equipment. (+Taka 3995.3 crore), Animal or vegetable fats and oils and their cleavage products; prepared edible fats; animal or vegetable waxes (+Taka 2834.3 crore), Prepared foodstuffs; Beverages, Spirits and vineger; Tobacco and manufactured tobacco substitues (+Taka 3050.6 crore), Miscellaneous Manufactured Articles (+Taka 161.2 crore), articles of stone, plaster, cement asbestos, mica or similar materials, ceramic products; glass and glassware (+Taka 226.4 crore), Arms and Ammunition; Parts and Accessories Thereof (++Taka 65.0 crore), Foot wear, headgear, umbrellas, sun umbrellas, walking sticks, seat-sticks, whips, ridding crops and parts thereof; (+Taka 59.7 crore), Natural or Cultured Pearls, Precious or Semiprecious Stones, Precious Metals, Metals Clad with Precious Metal and Articles thereof; Imitation Jewellery; Coin (+Taka 39.8 crore) and Works of Art, Collectors Pieces and Antiques (+Taka 68.5 crore).

The destinational pattern of imports during the year under review revealed that People's Republic of China topped the list of suppliers which earned Taka 109613.4 crore (or 25.3%) from export to Bangladesh during the year 2020-2021 as compared to Taka 97399.0 crore (or 25.2%) during the preceding year. The second highest seller was the India which supplied merchandise worth Taka 72878.2 crore (or 16.9%) during the year 2020-2021 under review as compared to Taka 49115.7 crore (or 12.7%) during the previous year.

Next to India, the third highest seller was Singapore which supplied merchandise worth Taka 20929.8 crore (or 4.8%) during 2020-2021 as compared to Taka 14547.6 crore (or 3.8%) during the preceding year.

United States of America (USA) being the fourth supplier in order of rank, sold goods worth Taka 19235.6 crore (or 4.4%) during 2020-2021 as compared to Taka 18029.5 crore (or 4.7%) during the previous year.

Japan fifth being the supplier in order of importance, sold goods worth Taka 16971.2 crore (or 3.9%) during 2020-2021 as compared to Taka 14591.6 crore (or 3.8%) during the previous year.


Indonesia, Brazil, Malaysia, United Arab Emirates (UAE), Korea republic of, Qatar, Canada, Saudia Arabia, Germany, Thailand, Australia, Taiwan: Province of China, Vietnam, Argentina and Pakistan followed in descending order of magnitude in respect of import payments and accounted for Taka 15651.3 crore (or 3.6%), Taka 14740.9 crore (or 3.4%), Taka 13344.2 crore (or 3.1%), Taka 11244.3 crore (or 2.6%), Taka 9554.2 crore (or 2.2%), Taka 8658.9 crore (or 2.0%), Taka 8470.7 crore (or 2.0%), Taka 8306.8 crore (or 1.9%), Taka 6749.5 crore (or 1.6%), Taka 6491.4 crore (or 1.5%), Taka 6362.7 crore (or 1.5%), Taka 6238.2 crore (or 1.4%) Taka 5755.1 crore (or 1.3%), Taka 5290.4 crore (or 1.2%) and Taka 4262.9 crore (or 1.0%) respectively.

The above 20 (twenty) countries being the 85.7 % supplier of goods worth Taka 370749.7 crore as compared to Taka 321819.1 crore (or 83.5%) during the previous year.

Import Payments classified by Bloc/Group/Community:

Import payments under cash, buyer's credit, loans & grants, IDB/ITFC loan and other unclassified imports when classified by countries in a bloc/group/economic cummunity revealed that the G-20 topped the list, selling goods worth Taka 320597.3 crore (or 74.0 %) of the total import payments during the period under review as compared to Taka 280749.2 crore (or 72.5 %) in the preceding year.

The second highest seller were the member countries of Other Asian Countries which accounted for an amount of Taka 145601.6 crore (or 33.6%) during the year under review as against Taka 131765.5 crore (or 34.0%) during the preceding year.

The third highest seller were the member countries of Organisation of Islamic Conference (OIC) which accounted for an amount of Taka 82228.2 crore (or 19.0%) during the year under review as compared to Taka 82093.1 crore (or 21.2%) during the preceding year.

The fourth highest seller were the member countries of Asian Clearing Union (ACU) which accounted for an amount of Taka 79360.3 crore (or 18.3%) during the year under review as against Taka 55673.7 crore (or 14.4%) during the preceding year.

SAARC, ASEAN, G-7, D-8, NAFTA and EU countries followed in descending order of magnitude in respect of import payments as follows: Taka 78708.1 crore (or 18.2%), 63783.5 core (14.7%), Taka 59827.9 crore (or 13.8%), Taka 37824.5 crore (or 8.7%), Taka 27916.4 crore (or 6.4%) and Taka 21883.8 crore (or 5.1%) respectively.

Table-V(A) (Taka in crore) and V(B) (In Million US\$) shows the comparative position of import payments to countries classified into bloc/group/community etc. during the year 2020-2021 and 2019-2020 alongwith their relative shares in the total import payments of Bangladesh.

Imports by Export Processing Zone (EPZ):

In order to achieve rapid economic growth of the country by increasing the inflow of foreign investment, particularly through industrialisation, special steps have been taken since 1980 by setting up Export Processing Zone (EPZ) in the country in Chittagong (Halishahar), Dhaka (Savar) and Khulna (Mongla) where favourable facilities/ assistance are provided to the potential investors, both Bangladeshi and foreigners. The Chittagong Export Processing Zone (CEPZ) started from 1983-84 while the Dhaka Export Processing Zone (DEPZ) started from 1993-94. Later, EPZs have also been established in Mongla of Khulna, Ishurdi of Pabna, Comilla, Uttara of Syedpur in the district of Nilphamary, Adamjee of Narayanganj and Karnaphuli of Chittagong where the investments are classified into three types i.e., A-type (100% foreign investment), B-type (Joint venture investment between Bangladeshi and foreigners) and C-type (100% Bangladeshi entrprenuer's investment).

At the end of June, 2021 type-wise number of functioning enterprises in EPZ area are shown in Table-VI.
