Highlights of Government Domestic Borrowing, June 2026

- **Government Domestic Borrowing** has been set at BDT 125000.0 crore in the national budget for FY26. Of which:
 - **Borrowing from the banking system** BDT 104000.0 crore.
 - **Borrowing from the non-banking sources** BDT 21000.0 crore (including BDT 12500.0 crore through net sales of National Savings Schemes).
- Government net borrowing from the **banking system** stood at BDT 131712.7 crore during July-June of FY26, whereas it was BDT 77108.1 crore in the same period of FY25.
- Government net borrowing from non-bank sources stood at BDT 191.8 crore during July-June of FY26, compared with BDT 42258.9 crore during the corresponding period of the previous fiscal year.
- Therefore, government **total net domestic borrowing** (both from the banking and non-banking sources) stood at BDT 131904.4 crore (105.5 percent of the budget target) during July-June of FY26. On the other hand, total net domestic borrowing was BDT 119367.0 crore (102.0 percent of the budget target) in the same period of FY25.
- Net borrowing of the national savings schemes stood at BDT 540.20 crore during July-June, FY26, whereas net repayment was BDT 6063.3 crore in the same period of FY25.

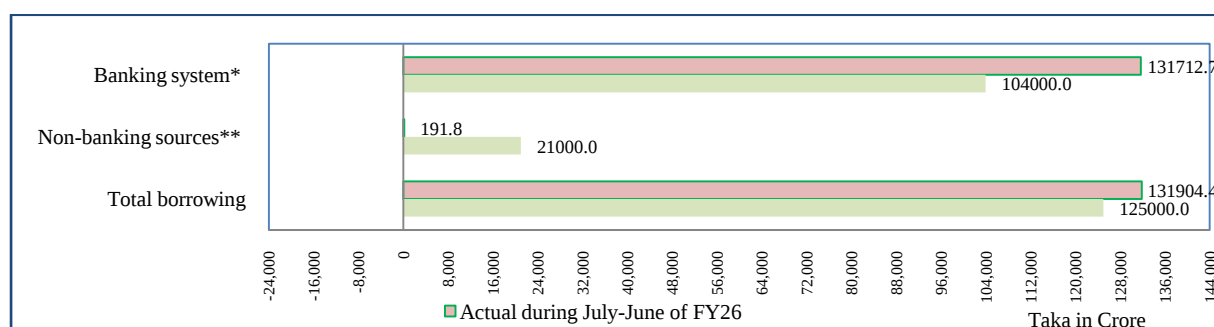
Government Domestic Borrowing, June 2026

Government borrows to finance its budget deficit mainly from two domestic sources: banking system and non-banking sources. Government borrowing from the banking system consists of borrowing from Bangladesh Bank and the scheduled banks. Government Borrows from the banking system mainly through ways and means advances, overdraft, and issuance of treasury bills (T-bills) and bonds (T-bonds). However, balances of government deposits and other funds in the banking system are net out from borrowing. On the other hand, the components of government borrowing from the non-banking sources are savings schemes introduced by the Department of National Savings (NSD) and T-bills and T-bonds held by non-bank finance companies, insurance companies, individual investors, etc.

1. Government Domestic Borrowing Target for FY26

In the national budget², the target of total domestic borrowing has been set at BDT 1,25,000.0 crore for FY26, of which BDT 1,04,000.0 crore was planned to borrow from the banking system and the rest BDT 21,000.0 crore from the non-banking sources. As per the latest available data, government domestic borrowing (net) stood at BDT 131904.4 crore in July-June of FY26 (Chart-1).

2. Borrowing from the Banking System

During July-June of FY26, government borrowing (net) from the banking system stood at BDT 131712.7 crore, compared to BDT 77108.1 crore during the same period of the preceding year, reflecting a sharp increase.

3. Borrowing from the Non-banking Sources

During July-June of FY26, the government repayment (net) was BDT 348.4 crore from different institutions and individuals other than banks through T-bills, T-bonds and BGIS. Moreover, sale and principal repayment of national savings schemes stood at BDT 92617.72 crore and BDT 92077.52 crore, respectively, in the same period of FY26, resulting in the net borrowing of national savings schemes of BDT 540.20 crore. Therefore, borrowing (net) from the non-banking sources stood at BDT 191.8 crore during July-June of FY26 whereas

government borrowed (net) BDT 42258.9 crore during the same period of the previous fiscal year.

4. Total Domestic Borrowing

Government borrowed BDT 131904.4 crore (net) from its domestic sources during July-June of FY26. Source and instrument-wise outstanding and flow of net government domestic borrowings are shown in Table-1 and Chart-2, respectively.

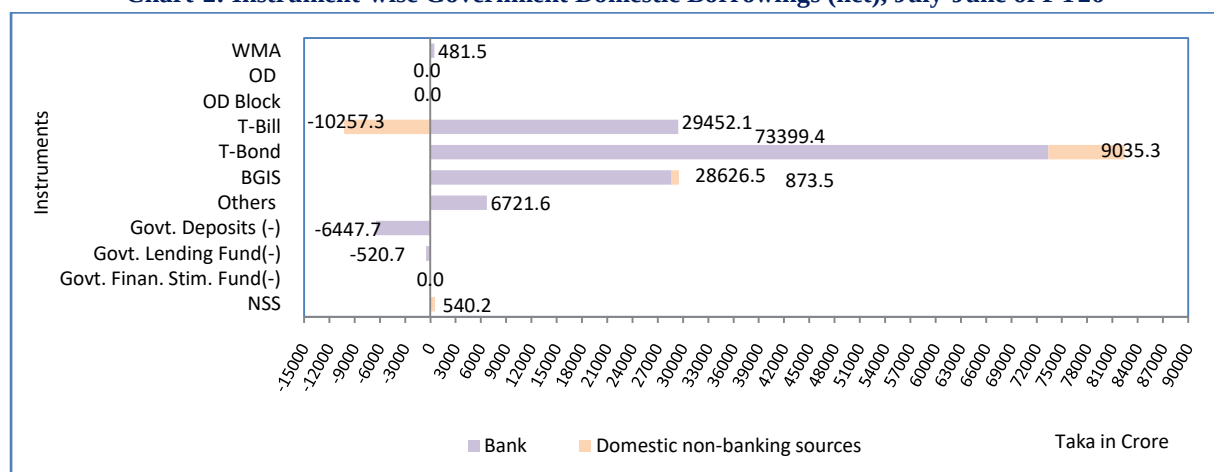

5. Government Islamic Securities

i) Bangladesh Government Islamic Investment Bond (BGIIB)³

For facilitating *Shariah*-based Islamic banks and windows which are not participants in the conventional money market, Bangladesh Government Islamic Investment Bond (BGIIB) was

initiated in 2004 to meet their liquidity needs. During July-June of FY26, investments in BGIIB fund by Islamic banks⁴ was BDT 5211.3 crore while the amount borrowed from the same fund was BDT 860.0 crore. Thus, Islamic banks' net balances of BGIIB fund was BDT 4351.3 crore during the period of July-June of FY26.

ii) Bangladesh Government Investment Sukuk (BGIS) Bond

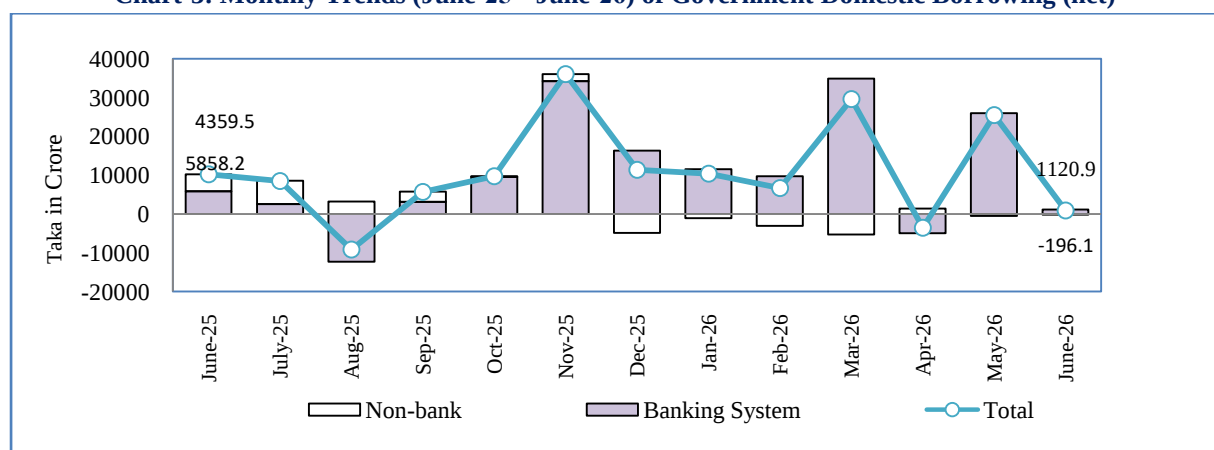
To support *Shariah*-based development finances, Bangladesh Government Investment *Sukuk* (BGIS) Bond was introduced in December 2020. So far, government issued eleven *Sukuk* (BGIS) bonds under *Ijarah, Istisna and Sale's* mode. The outstanding amount of *Sukuk* (BGIS) increased to BDT 53,500.0 crore as of end June, 2026.

6. Monthly Movements of Domestic Borrowing (June, 2026)

In June 2026, the government borrowed BDT 22,417.2 crore from the banking system and repaid BDT 21,296.3 crore, resulting in a borrowing (net) of BDT 1,120.9 crore. However, in June 2025, government borrowing (net) from the banking system stood at BDT 5,858.2 crore, of which the borrowing amount was BDT 24,549.2 crore and the repayment amount was BDT 18,691.0 crore (Chart-3).

On the other hand, in June 2026, government repayment (net) was BDT 196.1 crore from non-banking sources where borrowing amount was BDT 12,081.2 crore and repayment amount was BDT 12,277.3 crore. In June 2025, government borrowed BDT 11,286.0 crore and repaid BDT 6,926.4 crore, leading to borrowing (net) of BDT 4359.6 crore from the same sources (Chart-3).

7. Concluding Remarks

Government domestic borrowing from the banking system during July-June of FY26 increased sharply compared to the same period of FY25. However, government borrowing from the non-banking sources during the reported period was significantly lower than that in the corresponding period of FY25.
