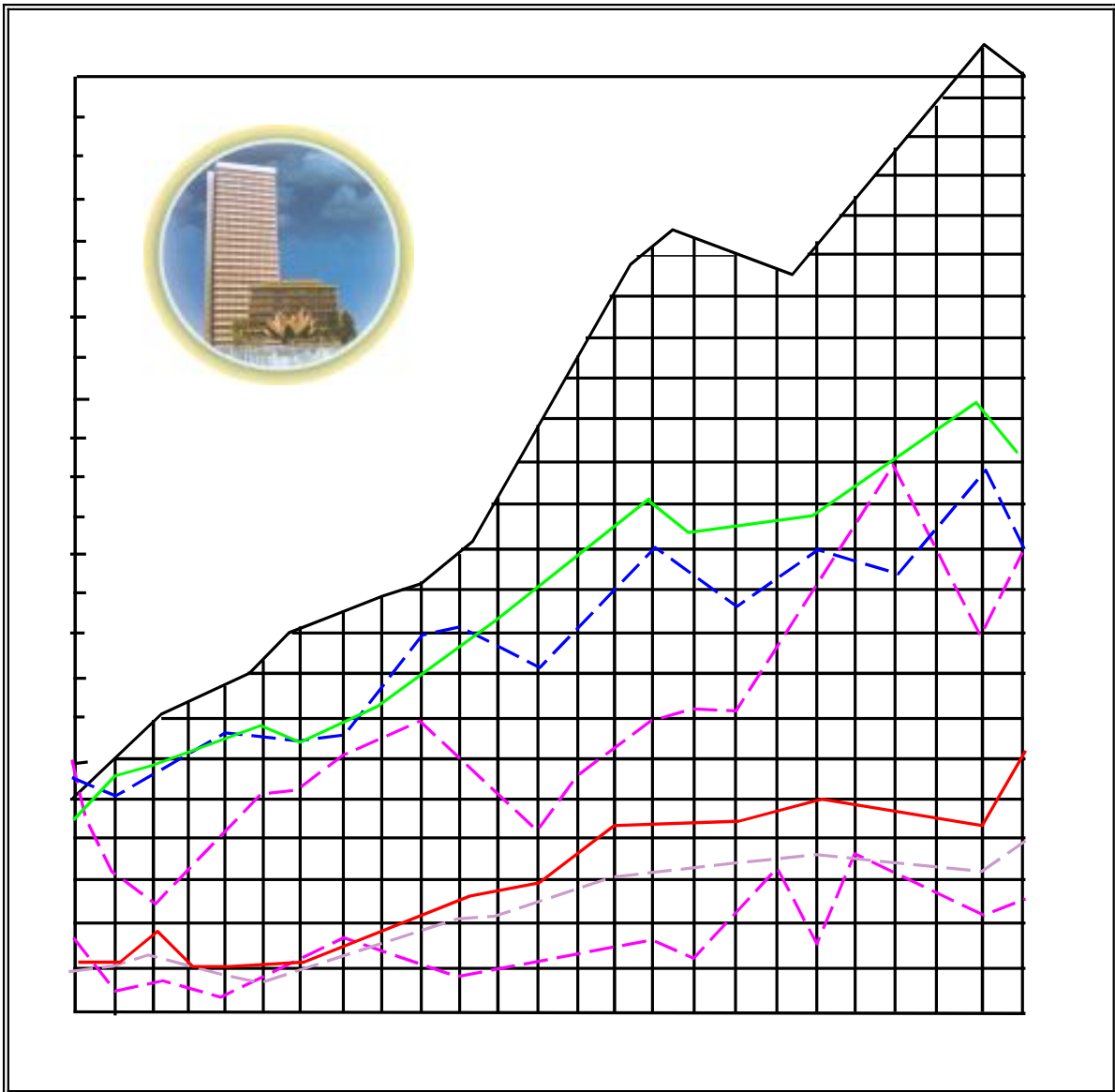

Executive summary

1. Broad money recorded an increase of Tk.20784.30 crore or 4.72 percent during July-October, 2011 against the increase of Tk. 22200.10 crore or 6.12 percent during July-October, 2010. Of the components of broad money, currency outside banks rose by Tk. 4678.00 crore or 8.54 percent and deposits increased by Tk. 16106.30 crore or 4.18 percent; of which, time deposits increased by Tk. 15867.50 crore or 4.70 percent and demand deposits increased by Tk.238.80 crore or 0.49 percent .

Domestic credit recorded an increase of Tk.28662.50 crore or 6.61 percent during July-October, 2011 against the increase of Tk. 23873.60 crore or 7.02 percent during July-October, 2010. The rise in domestic credit during the period under report was due to the rise of private sector credit by Tk. 16206.90 crore or 4.76 percent and public sector credit by Tk.12455.60 crore or 13.42 percent. In the components of credit to the public sector, credit to the Govt.(net) increased by Tk. 14367.70 crore or 19.56 percent. However, credit to the 'other public sector' decreased by Tk. 1912.10 crore or 9.87 percent.

2. Total tax revenue collection in August, 2011 increased by Tk.449.05 crore or 7.94 percent to Tk.6105.58 crore, against Tk.5656.53 crore in August, 2010. The NBR and Non-NBR tax revenue collection during July-August, 2011-12 were Tk.11521.77 crore and Tk.530.49 crore respectively, against Tk.9938.63 crore and Tk.513.95 crore respectively during July-August, 2010-11.

NBR tax revenue collection in October, 2011 stood higher by Tk.251.71 crore or 3.83 percent to Tk.6824.71 crore against Tk.6573.00 crore collected in September, 2011. This was also higher by Tk. 1139.24 crore or 20.04 percent against collection of Tk.5685.47 crore in October, 2010. Total NBR tax revenue collection during July-October, 2011-12 increased by Tk. 3543.07 crore or 16.57 percent to Tk. 24919.48 crore against collection of Tk. 21376.41 crore during July-October, 2010-11. Target for NBR tax revenue collection for FY 2011-12 is fixed at Tk. 91870.00 crore.

Outstanding borrowing of the government through NSD certificates as of end September, 2011 stood at Tk.63936.75 crore, recording an increase of Tk.1122.10 crore or 1.79 percent against Tk.62814.65 crore as of end September, 2010.

3. Exports receipts during July-October, 2011-12 increased by US\$1397.10 million or 20.79 percent to US\$8118.51 million as compared to US\$6721.41 million during July-October, 2010-11.

4. Import payments during July-September, 2011-12 increased by US\$1740.70 million or 24.79 percent to US\$8762.40 million compared to US\$7021.70 million during July-September, 2010-11

Settlement of import LCs during July-September, 2011-12 increased by US\$1605.49 million or 23.18 percent to US\$8530.46 million against US\$6924.97 million during July-September, 2010-11

Fresh opening of import LCs during July-September, 2011-12 increased by US\$944.17 million or 10.53 percent to US\$9913.90 million against US\$8969.73 million during July-September, 2010-11

5. Remittances receipts during July-October, 2011-12 increased by US\$429.50 million or 11.99 percent to US\$ 4012.29 million against US\$3582.79 million during July-October, 2010-11.

6. Gross foreign exchange reserves of the BB stood higher at US\$10338.28 million (with ACU liability of US\$ 824.05 million) as of end October, 2011, against US\$9883.59 million (with ACU liability of US\$ 419.61million) by end September, 2011. The gross foreign exchange reserves, without ACU liability is equivalent to import payments of 3.23 months according to imports of US\$ 2949.85 million per month based on the previous 12 months average (October-September, 2010-11).

Gross foreign exchange balances held abroad by commercial banks stood higher at US\$ 1093.40 million by end October, 2011 against US\$991.10 million by end September, 2011. This was also higher than the balance of US\$583.21 million by end October, 2010.

7. The annual average rate of inflation (12-month annual average CPI, 1995-96=100) increased to 10.18 percent in October, 2011 from 9.79 percent of September, 2011.

The rate of inflation on point to point basis slightly decreased to 11.42 percent in

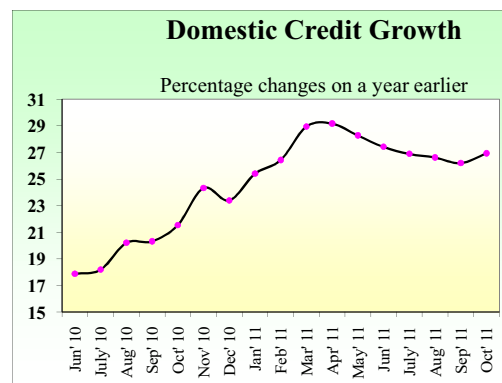
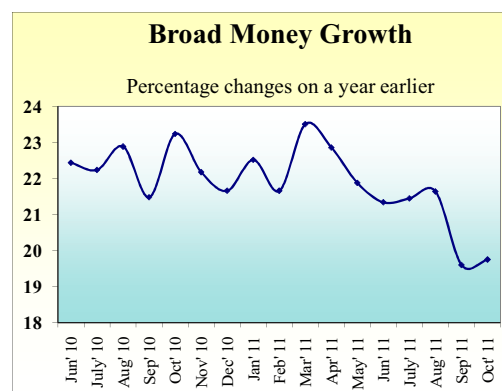

Broad money

Broad money recorded an increase of Tk.20784.30 crore or 4.72 percent during July-October, 2011 against the increase of Tk. 22200.10 crore or 6.12 percent during July-October, 2010. Of the components of broad money, currency outside banks rose by Tk. 4678.00 crore or 8.54 percent and deposits increased by Tk. 16106.30 crore or 4.18 percent; of which, time deposits increased by Tk. 15867.50 crore or 4.70 percent and demand deposits increased by Tk.238.80 crore or 0.49 percent.

Domestic credit

Domestic credit recorded an increase of Tk.28662.50 crore or 6.61 percent during July-October, 2011 against the increase of Tk. 23873.60 crore or 7.02 percent during July-October, 2010. 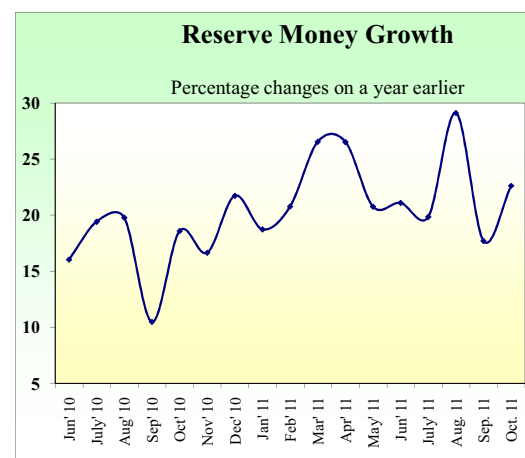

Reserve Money

Reserve money recorded an increase of Tk.2502.70 crore or 2.57 percent during July-October, 2011 compared to the increase of Tk.1043.20 crore or 1.30 percent during July-October, 2010. The increase of reserve money growth occurred mainly due to increase in net domestic assets of Bangladesh Bank Tk. 3913.20 crore or 10.84 percent. However, net foreign assets of Bangladesh Bank decreased by Tk. 1410.50 crore or 2.30 percent during the period under report.

Reserve money multiplier increased to 4.61 at the end of October, 2011 from 4.52 of June, 2011.

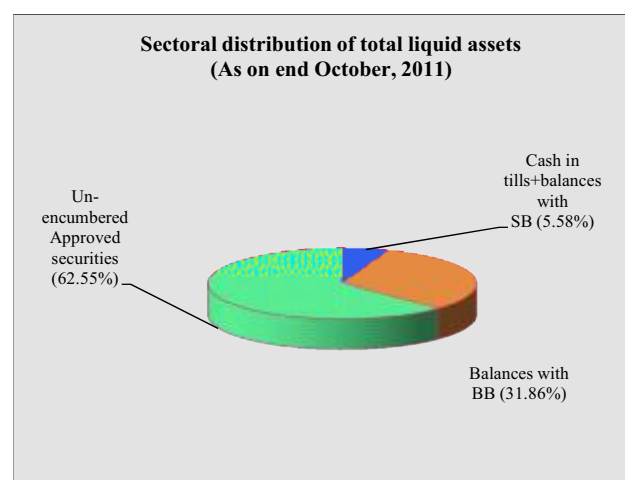
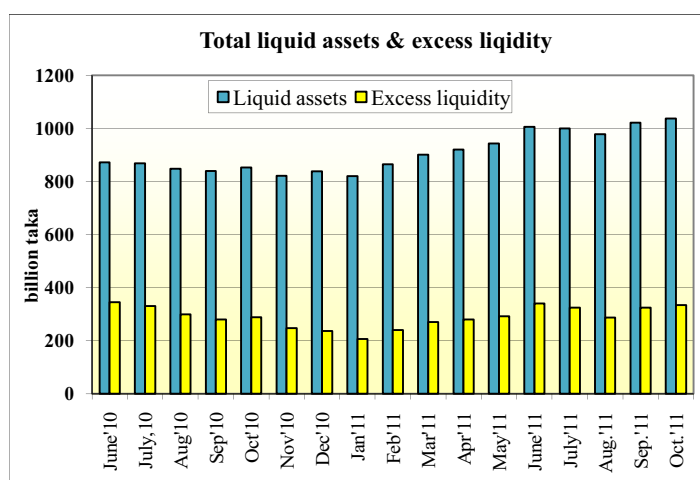

Total liquid assets of the scheduled banks stood higher at Tk. 103745.76 crore as of end October, 2011 against Tk.100564.96 crore as of end June, 2011. However, excess liquidity of the scheduled banks stood lower at Tk.33454.05 crore as of end October, 2011 against Tk.34071.21 crore as of end June, 2011.

Scheduled banks holding of liquid assets as of October, 2011 in the form of cash in tills & balances with Sonali bank, balances with Bangladesh Bank and unencumbered approved securities are 5.58 percent, 31.86 percent and 62.55 percent respectively of total liquid assets.

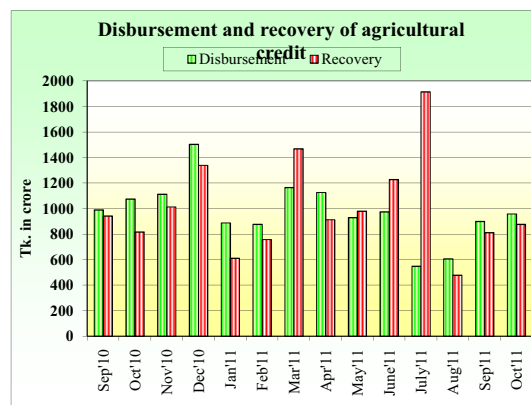

Disbursement of agricultural credit during July-October, 2011 stood lower at Tk.3010.29 crore as compared to Tk.3608.39 crore during July-October, 2010. However, recovery of agricultural credit during July-October, 2011 stood higher at Tk.4081.45 crore as compared to Tk. 3838.48 crore during July-October, 2010. The position of overdue agricultural credit as percentage of total outstanding slightly slipped, increasing from 29.31 at the end of October, 2010 to 29.60 at the end of October, 2011.

Disbursement of industrial term loans during July-September 2011 stood lower at Tk.7437.44 crore as compared to Tk.7473.51 crore during July-September, 2010. However, recovery of industrial term loans was higher at Tk.6810.88 crore during July-September, 2011 against Tk.5913.87 crore during July-September, 2010.

Overdue of industrial term loans at the end of September, 2011 stood at Tk.6868.72 crore which was 9.93% of the outstanding position at the end of September, 2011.

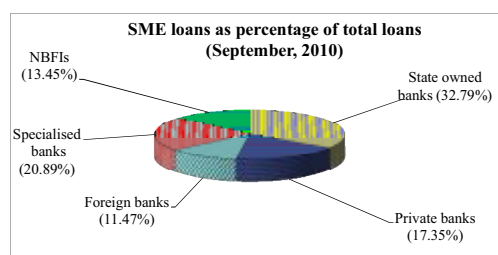
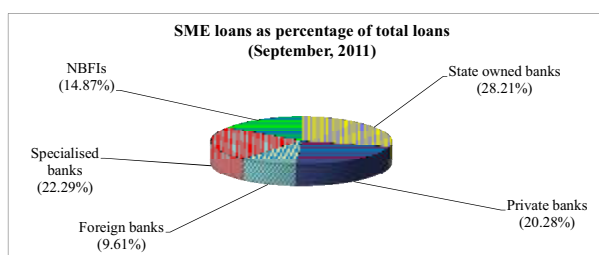

Total SME loans increased by Tk.17645.30 crore or 29.05 percent to Tk.78379.74 crore at the end of September, 2011 as compared to Tk.60734.44 crore at the end of September, 2010. Institutional category-wise SME loans increased at the end of September, 2011 in private banks (+42.01), non-bank financial institutions (+30.59%), specialised banks (+29.36%), state owned banks (+10.59%) and foreign banks (+1.89%) as compared to September, 2010.

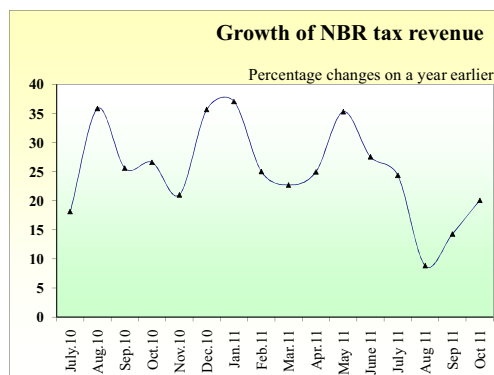
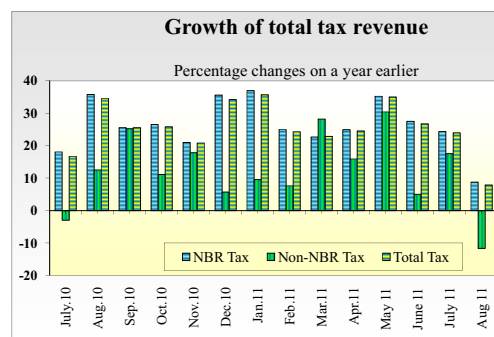

The NBR and Non-NBR tax revenue collection during July-August, 2011-12 were Tk.11521.77 crore and Tk.530.49 crore respectively, against Tk.9938.63 crore and Tk.513.95 crore respectively during July-August, 2010-11.

NBR tax revenue collection in October, 2011 stood higher by Tk.251.71 crore or 3.83 percent to Tk.6824.71 crore against Tk.6573.00 crore collected in September, 2011. This was also higher by Tk. 1139.24 crore or 20.04 percent against collection of Tk.5685.47 crore in October, 2010. Total NBR tax revenue collection during July-October, 2011-12 increased by Tk. 3543.07 crore or 16.57 percent to Tk. 24919.48 crore against collection of Tk. 21376.41 crore during July-October, 2010-11. Target for NBR tax revenue collection for FY 2011-12 is fixed at Tk. 91870.00 crore.

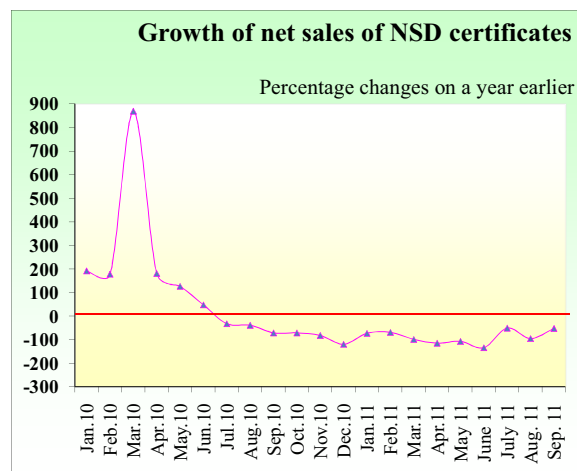

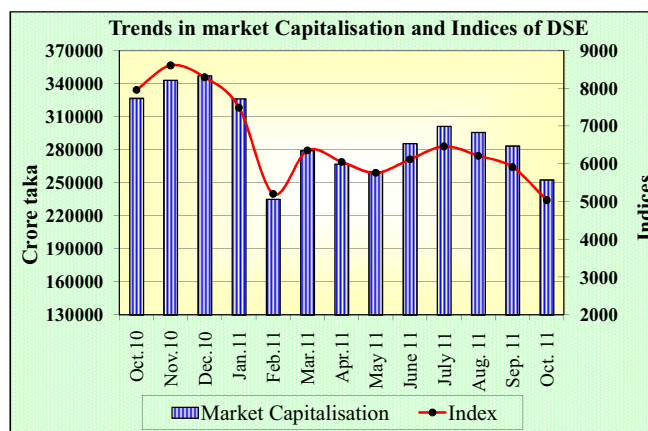

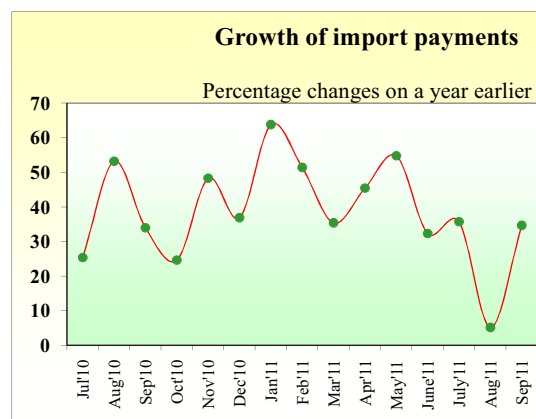

Import payments in September, 2011 stood higher by US\$719.00 million or 28.17 percent to US\$3271.80 million, against US\$2552.80 million in August, 2011. This was also higher by US\$842.10 million or 34.66 percent than US\$2429.70 million in September, 2010. Import payments during July-September, 2011-12 increased by US\$1740.70 million or 24.79 percent to US\$8762.40 million compared to US\$7021.70 million during July-September, 2010-11. Of the total import payments during July-September, 2011-12 imports under Cash and for EPZ stood at US\$8250.20 million, import under Loans/Grants US\$29.40 million, import under direct investment US\$26.20 million and short term loan by BPC US\$456.60 million.



Settlement of import LCs in September, 2011 stood higher by US\$359.44 million or 13.36 percent to US\$3049.81 million compared to US\$2690.37 million in August, 2011. This was also higher by US\$632.11 million or 26.15 percent against US\$2417.70 million in the same month of the previous year. Settlement of import LCs during July-September, 2011-12 increased by US\$1605.49 million or 23.18 percent to US\$8530.46 million against US\$6924.97 million during July-September, 2010-11.

Fresh opening of import LCs in September, 2011 stood higher by US\$378.82 million or 11.91 percent to US\$3560.69 million compared to US\$3181.87 million in August, 2011. This was also higher by US\$733.34 million or 25.94 percent than US\$2827.35 million in the same month of the previous year. Fresh opening of import LCs during July-September, 2011-12 increased by US\$944.17 million or 10.53 percent to US\$9913.90 million against US\$8969.73 million during July-September, 2010-11.

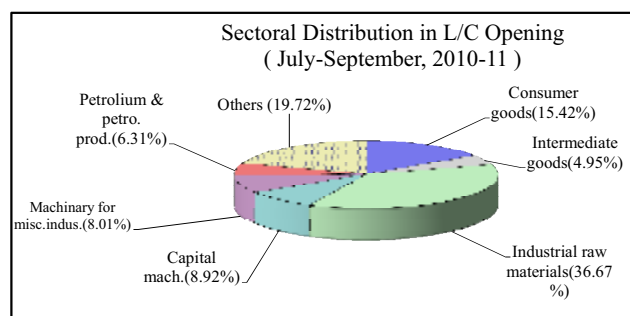

Remittances in October, 2011 stood higher at US\$1039.48 million against US\$855.44 million of September, 2011. This was also higher by US\$115.63 million against US\$923.85 million of October, 2010.

Total remittances receipts during July-October, 2011-12 increased by US\$429.50 million or 11.99 percent to US\$ 4012.29 million against US\$3582.79 million during July-October, 2010-11.

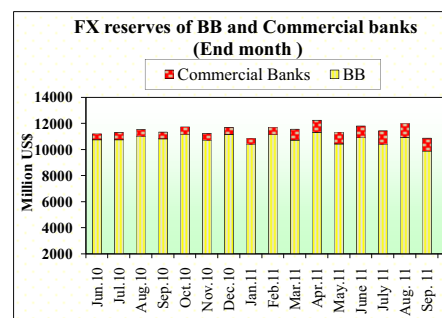

The gross foreign exchange reserves of the BB stood higher at US\$10338.28 million (with ACU liability of US\$ 824.05 million) as of end October, 2011, against US\$9883.59 million (with ACU liability of US\$ 419.61million) by end September, 2011. The gross foreign exchange reserves, without ACU liability is equivalent to import payments of 3.23 months according to imports of US\$ 2949.85 million per month based on the previous 12 months average (October-September, 2010-11).



(b) Gross foreign exchange balances held abroad by commercial banks :

The gross foreign exchange balances held abroad by commercial banks stood higher at US\$ 1093.40 million by end October, 2011 against US\$991.10 million by end September, 2011. This was also higher than the balance of US\$583.21 million by end October, 2010.

Trade balance recorded a higher deficit of US\$1814 million during July-September , 2011-12 compared to the deficit of US\$1469 million during July-September, 2010-11. However, due to a large secondary income of US\$3241 million current account balance recorded a surplus of US\$307 million during July-September, 2011-12 against the surplus of US\$622 million during July-September, 2010-11. Despite of a surplus of US\$307 million in current account , due to US\$272 million deficit in financial account and large negative in errors and omissions the overall balance showed a deficit of US\$400 million during July-September, 2011-12 against the deficit of US\$426 million during July-September , 2010-11.

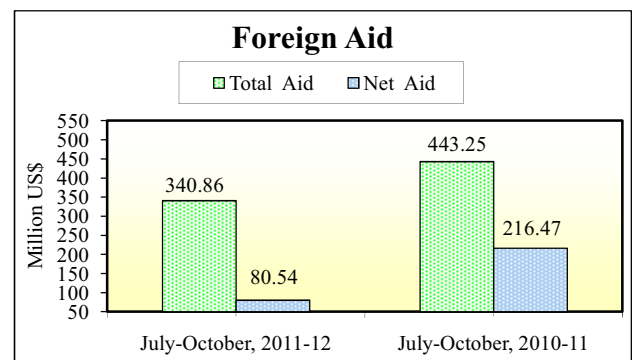

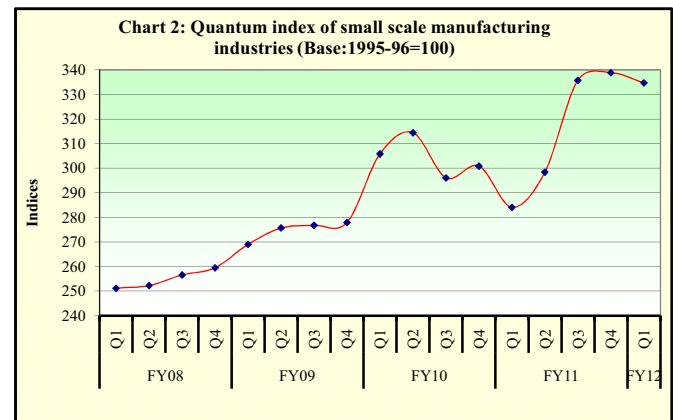
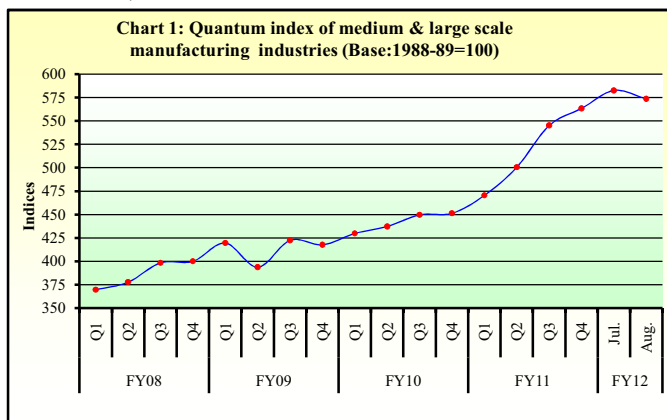

The general index of industrial production (medium & large scale manufacturing) stood higher at 545.83 during July-August, 2011-12, recording an increase of 11.59 percent over July-August, 2010-11.

Indices recording increases during July-August, 2011-12 compared to the same period of the preceding year are : Jute, cott. w. applr & leather (+17.59%), Basic metal product (+14.33), Chemical, petro. & rubber (+11.50%) and Food beverage & tobacco(+0.24%) . On the other hand indices of Paper & paper prod decreased by 2.29 percent, Non-metalic product decreases by 1.47 percent, Fabricated metal product decreased by 1.06 percent and Wood product incl. furniture decreased by 0.87 percent during July-August, 2011-12 compared to the same period of the previous year.

The general index of small scale manufacturing industry during the first quarter (July-September) of FY12 decreased by 1.21 percent to 334.76 as compared to 338.87 during the fourth quarter of the previous fiscal year. However, this was increased by 17.84 percent as compared to 284.09 during the same quarter of the previous fiscal year.

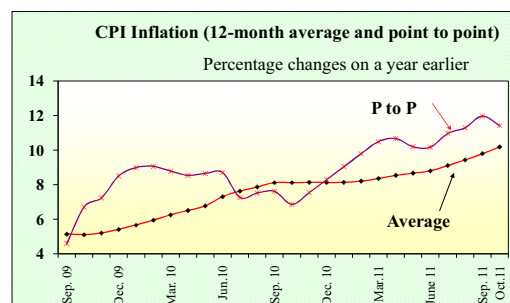

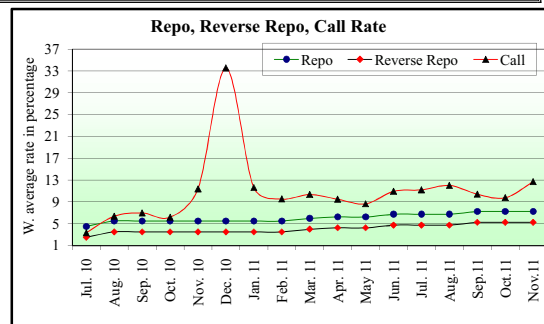

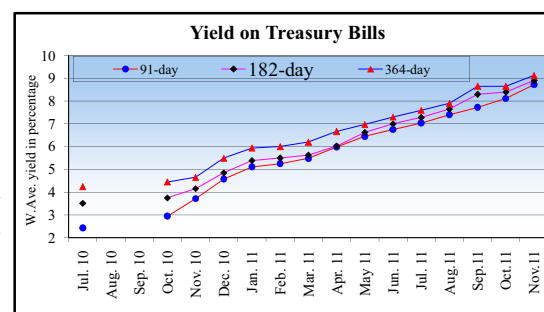

Repo rate (1-3 Day tenure) and reverse repo rate (1-3 Day tenure) increased by 50 basis point at 7.25 percent and 5.25 percent from 5 September, 2011 as compared to 6.75 percent and 4.75 percent respectively in 4 September, 2011. The weighted average call money rate in the inter-bank money market increased to 12.70 percent in November, 2011 as compared to 9.77 percent in October, 2011.

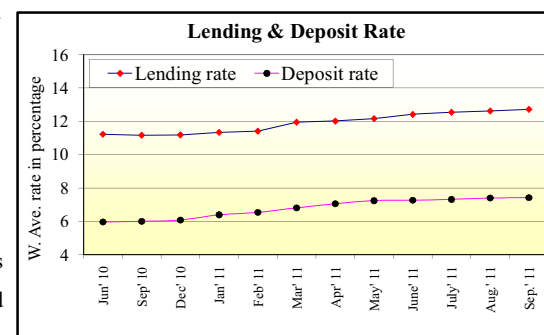

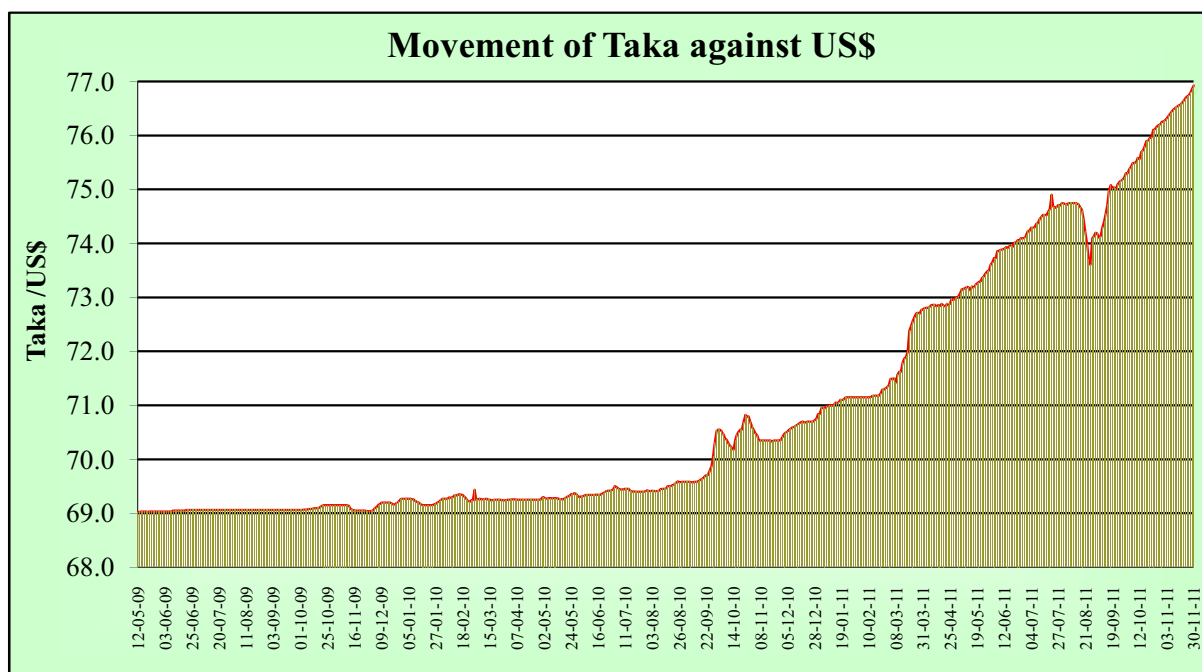
